1 Register of Interests

2 Sensitive Interests

Where you consider that disclosure of the details of an interest could lead to you, or a person connected with you, being subject to violence or intimidation, and the Monitoring Officer agrees, if the interest is entered on the register, any copy of the register that is made available for inspection and any published version of the register will exclude details of the interest.
